TAXES

We have been hit with a Federal fuel tax increase of five cents per gallon, a luxury tax of 19% of the price of new boats over 100,000, and a Coast Guard Users Fee from \$25 to \$100 as a function of length. Maryland is proposing an additional 5% sales tax on fuel in addition to the 18.5 cents per gallon they already get. Shaefer is proposing a 2% annual personal property tax on the book value of your cars and boats.

We can stop the increase in Maryland taxes. Maryland Speaker of the House, R. Clayton Mitchell has taken a stand of NO NEW TAXES THIS YEAR. He needs our support! Call His office at Balt area, 841-3800; Wash DC area, 858-3800 and all other 1-800-492-7122, ext.3800.

Dear

The last Congress enacted a so-called Coast Guard Users Fee. This is neither a users fee nor does it benefit the Coast Guard. It is a repressive and discriminatory TAX. It is repressive because the recreational boating industry is already depressed, and discriminatory because no other recreational activity has been so taxed. Tennis, baseball, football, mountain climbing, etc. or even recreational vehicles are not so taxed. These tax proceeds go into the general fund, not into the Coast Guard Budget. There is a specific disclaimer against guaranteeing any Coast Guard service to recreational boats as a result of this.

It is easy to picture recreational boaters as owning luxury yachts as, certainly, some do. Most do not. The average size of a recreational boat in the United States is 16 feet. All boat owners pay Wallop-Breaux, fuel taxes, and some pay registration fees at the Federal level. Boaters pay fuel tax, excise tax, registration fees and license fees at the state level as well.

At the present time it is widely accepted that with every 1% increase in the price of a boat sales decrease 2%. The "Users Fee" is an annual tax that will further depress sales in an already depressed market.

HR 534 has been filed with the purpose of repealing the "Users Fee". It has been sponsored in the House initially by Representatives Herbert Bateman and Robert W. Davis and is already gathering support in the house. It is my hope that it will be passed this session. I urge you to support HR 534 and to use your considerable influence to urge others to do likewise.


